




- 1. (Preliminary Market Engagement Notices) If the contracting authority chooses not to carry out premarket engagement it must explain why in the Tender Notice. (Modified Contract Copy) A 'qualifying modification' is one that required you to publish a Contract Change Notice or changes a contract that is over £5m or becomes over £5m after the modification. This does not apply to changes to certain devolved
- 7. (Payments Compliance Notices) This notice must information about compliance with your obligation to pay within 30 days of becoming due. A 'reporting' period is each 6 month period ending 31st March and 30th September. 8.
